

Information on the notarial deed for usage of donor sperm

The Austrian Reproductive Medicine Act states special provisions for the use of sperm cells from a third party. These couples need to have a notary deed for the settlement of parenthood drawn up for treatments with insemination or in-vitro fertilisation (IVF). Further information on the legal basis can be found by scanning the QR code.



Important information

- A valid notary deed has to be present at the start of treatment.
- A treatment cannot be conducted in case of a missing or expired notary deed (no exceptions)!
- Please note that the notary deed has a **validity of two years** as regulated by law.
- The notary deed as an original or notarial certified copy stays at the Kinderwunschzentrum an der Wien.
- For foreign citizens: in some cases, special legal provisions according to the law of your home country have to be drawn up. Additionally, without sufficient German language skills a court translator is required. Both issues can lead to further costs and longer waiting periods, please let your notary know in good time!
- If your partner is also planning treatment under certain circumstances, you can have the notarial deed issued reciprocally.

What do you need to do now?

- **1.** Please make an appointment with a notary in Austria. You will need your photo ID cards or passports for this appointment.
- **2.** Send the completed and signed consent form on the back page to your notary. This allows the advance transmission of the notary deed to us via e-mail.
- **3.** Optional: If you require interpretation according to the law of your home country or a translator, please let the notary know this in advance.
- **4.** Please bring the original copy of the notary deed to your next appointment at the Kinderwunschzentrum an der Wien.
